

ZINAPAH Brief History Mission, Vision and Values



About ZINAPAH

ZINAPAH was founded in 2017 to provide stable, equitable compensation for the well-being of 1st and 2nd group disabled servicemen and the families of fallen and missing servicemen while defending the homeland and its borders for the peace and security of future generations.

In April 2023, the Foundation previously known as Insurance Foundation for Servicemen (IFS) was renamed ZINAPAH – National Foundation for Servicemen Insurance. ZINAPAH is a non-political institution that operates according to the <u>Law</u>.

It is a unique foundation in the region where every working citizen in Armenia is required to make mandatory contributions from their salaries. **ZINAPAH** represents a pan-Armenian effort to ensure financial well-being for those who have sacrificed their lives for the security of Armenia.

ZINAPAH funds are generated from:

- Mandatory monthly payments from 1,500 to 15,000 AMD per month (based on the amount of income) by taxpayers in Armenia
- **Over the World**, including Armenia
- **ZINAPAH** asset management appreciation

ZINAPAH is governed by an independent <u>Board of Trustees</u> (BoT), consisting of highly-regarded professionals with stellar reputations and expertise in Finance & Banking, Business, Crisis Management, Fundraising, and Asset Management.

ZINAPAH is operated by a highly motivated and experienced Executive Team of young professionals. <u>ZINAPAH's website</u> provides the possibility to monitor both total funds from mandatory payments and donations, as well as the list of compensations. The CEO <u>Quarterly</u>, <u>Annual reports</u>, as well as the <u>Annual Audit report</u> conducted by one of the top 10 worldwide known audit firms, are also regularly published on the ZINAPAH website.

As we reflect on 2023, I am filled with profound gratitude and admiration for the unwavering support of our incredible community - every taxpayer in Armenia, our donors from all over the world, the Republic of Armenia State bodies, and our partner organizations. Thanks to your generosity and dedication we have fulfilled our mission in the past year.

We at ZINAPAH National Foundation for Servicemen Insurance are grateful for your attention and continuous support. Your backing enables us to pursue financial support and social integration programs for our servicemen and their families.

On behalf of the entire ZINAPAH Team, I am honored to present our achievement in the current report for 2023.

After the 2020 War, 2021 was a year of operational and structural crisis management for **ZINAPAH National Foundation for Servicemen Insurance**. 2022-2023 was a period for recovery in terms of buffering, managing assets, and making monthly regular compensations while continuing to restructure and institutionalize ZINAPAH to focus on its core function as a financial support organization. Since 2017-2023 ZINAPAH has provided compensation to 5,198 individuals, amounting to 85.7B AMD. Approximately 138.4B AMD was generated from mandatory payments, 16B AMD from asset management, and around 9.4B AMD from donations.

ZINAPAH did a great deal of good in 2023, to compensate 109 new beneficiaries. The generated funds from mandatory payments were at 43.2B AMD, from asset management at 5.9B AMD, and 273mln AMD from donations.

The geo-political security situation remains dangerous and precarious, and our servicemen are heavily at risk to maintain stability and security. We at ZINAPAH remain committed to our mission and with your continued support, we will achieve our mission.

We at ZINAPAH are profoundly grateful and indebted to you for yet another year of support, which enables us to financially support our beneficiaries and pursue our most ambitious programs.

Let us stand united, bound by a shared purpose and vision of empowering ZINAPAH beneficiaries and their families.

ZINAPAH Operations for 2017 - 2023



As per the 2023 year-end actuals, ZINAPAH recorded growth in income by approximately 26% in 2023 vs the previous year (PY), with about 49,654 mln AMD due to the strong increase in mandatory payments by 22%, asset management income growth by 83% and despite the decline in donations by 46%, which is an organic slowdown given that no investments were made to support the donor base, as well as the post-war declining trend mentioned in the previous reports.

In 2023, the portion of ZINAPAH income attributable to mandatory payments is at 87% vs. 90% in 2022. Asset management income grew by about 4 percentage points from 8% in 2022 to 12% in 2023, and the income attributable to donations went down by 0.7 points from 1.3% in 2022 to 0.6% in 2023.

ZINAPAH expenses declined to 15,084 mln AMD by 12% vs PY and the compensation declined by 13%, which is explained by the low level of estimated cases (i.e. lump-sum payments). The administrative expense grew by 8% and it is lower than the projected budget of 33%. This is mainly explained by the increase in the outsourced service fees, staff headcount cut-related payments in Q1 2023, adjustments to bring salaries to the market average and in-house transfer of the stamp payment return service.

The admin expenses vs total assets ratio for 2023 is at 0.58% vs the 2% upper cap limit regulated by the law.




ZINAPAH Operations for 2017 - 2023



The graph below illustrates ZINAPAH's actual income and expenses from 2017 to 2023, segmented by each year.

In 2023, ZINAPAH experienced a 26% increase in total income, reaching 49,654 mln AMD. Simultaneously, total expenses saw a 12% reduction compared to 2022, amounting to 15,084 mln AMD.



The income growth of 26% in 2023 is mainly attributable to the 22% growth in mandatory payments and it is explained by the following factors:

- Increase in the total number of employed population by 5%, to 743K*
- Increase in number of companies by 6%, to 67.8K*
- Increase in the average salary size by 11%, to 274* AMD

ZINAPAH Operations for 2017 - 2023 Q4 vs PY



As of Q4 2023 vs PY results, ZINAPAH achieved income growth of around 15% totaling 12,301 mln AMD. This was attributed to a robust 8% rise in mandatory payments, an 86% increase in asset management income, despite a 34% decrease in donations.

At the same time, total expenses decreased by 37% to 3,688 mln AMD, and the compensations decreased by 38% as the monthly payments were the big chunk of the compensation vs lump sum payments, due to the low number of cases.

In 2023 Q4 the portion of ZINAPAH income attributable to mandatory payments is 84% vs 90% in 2022. The portion of income attributable to asset management increased to 15% with +6 ppts, and the portion of donations is stable at 1%. The administrative expenses decreased by 14% and the OpEx decreased by 61%. The high percentage increase of CapEx is explained by the prepayment for website development, and it was financed by the CBA in 2021.








ZINAPAH Beneficiaries and Compensations, 2017-2023

Donations to ZINAPAH, 2017-2023




From 2017 through 2023, the total donations received by ZINAPAH amounted to approximately 9.4 bln AMD.

The cumulative count of donations stands at nearly 88,000, with an average donation amounting to 106,000 AMD. The majority of donations occur during periods of escalations.

In 2023 compared to PY, the donation value decreased by 46% in AMD. The number of donations decreased by 59% and the average donation size increased by 31%. The decrease is explained by post-war syndrome, with donations usually showing a sharp increase in wartime, as reflected in the 2020 results. The biggest chunk of the decline is also reported in Russian Rubles from Russia due to the sanctions against Russia and the difficulties in money transfer systems. The donations were made via bank transfers as well as via the ZINAPAH website www.zinapah.am.

- The total number of returns showed a growth of 40% vs PY and the value of returns grew by 43%.

ZINAPAH Beneficiary Social Projects and Cooperation, Q4 2023



ZINAPAH continues to cooperate with various foundations, non-governmental and charitable organizations, and private sector companies to support our servicemen and their families for the further development of their physical, educational, psychological well-being and development.

Considering the importance of maintaining a connection with beneficiaries, the ZINAPAH team has taken steps for further social development and integration programs for its beneficiaries. ZINAPAH continues to work on expanding the list of cooperating partner organizations and signs a Memorandum of Understanding (MOU) on cooperation with each of them. The goal is to unite, consolidate, and coordinate existing public, private sector, NGO sector and charitable organizations around the idea of supporting servicemen and their families, and smoothly integrate them into society.

ZINAPAH Initiative / Financial Literacy

On 3 November 2023, a two-day online course on financial literacy was organized by ABC Finance, RA Central Bank of Armenia in cooperation with ZINAPAH and Educational Mission NGO. ZINAPAH and Educational Mission NGO beneficiaries, including 25 1st, 2nd and 3rd group disabled war participant servicemen attended the course.

The course was led by Araks Manucharyan, Senior Specialist of the Financial Education and Protection Center of the Financial System Stability and Regulation Department of the CBA. The course aimed to increase financial literacy, to introduce the techniques of personal/family finance management through non-professional knowledge. This will allow the ZINAPAH beneficiaries to make more responsible decisions about their finances in the future.

Given the overwhelmingly positive feedback from the course, similar courses will be scheduled in the future.

Armenian Spiritual Revival Foundation

In Q4 2023, the **Armenian Spiritual Revival Foundation** organized a series of community meetings in a unique spiritual and psychological Narrative format. The meeting aimed to support the ones who have post-war traumatic syndromes and the ones who directly participated in the war operations, their family members, and forcibly displaced people from Artsakh. Thanks to the joint efforts, about 60 beneficiaries of ZINAPAH participated in the meetings. Many of them expressed willingness to continue the group therapies after those primary meetings.

Some community meetings were held in Masis, Abovyan, Yerevan and Armavir, Gyumri, Vanadzor. ZINAPAH participated in the meetings held in Gyumri and Vanadzor. A few episodes from these two meetings are covered under the <u>video link</u>.







On November 30, 2023, the launch of ZINHUB online platform was announced. ZINHUB was developed in partnership with the Ministry of Labor and Social Affairs of the Republic of Armenia, ZINAPAH National Foundation for Servicemen Insurance and The 'Enterprise Incubator Fund a joint effort under the 'Workforce Development in Armenia program. The event was attended by high-ranking officials, representatives of partner NGOs, and other stakeholders.

ZINHUB online platform allows war participants and their family members as well as vulnerable groups of people to participate in various educational courses and gain new skills and competencies to become compatible in the labor market.

Member organizations can register in the platform and publish educational courses and training programs as well as offer job opportunities. ZINHUB users can easily navigate the platforms and locate announcements about available job offers and courses. The platform has various menus for courses and other projects.

HAYORDI Initiative - My New Year

From December 16, 2023, to January 2, 2024, HAYORDI collaborated with ZINAPAH and several public/charity organizations to arrange New Year shows for approximately **700 children** who are beneficiaries of ZINAPAH. These include siblings of fallen or missing servicemen and Armenians forcibly displaced from Artsakh. The children had the delightful experience of attending the enchanting "My New Year" musical specially designed for kids and youth at the State Theater of Music. The event left the young audience brimming with positive energy, and they received delightful gift boxes to complete the festive experience.







HAYORDI initiative - Puppet Theater

On December 27, 2023, Hayordi with the support of ID Bank, Idram Junior and Idram Payment System became Secret Santas for 250 children affected by the war. The children were invited to the "Santa's Gifts" colorful show at the Yerevan State Puppet Theater after Hovhannes Tumanyan. After the performance, the children received personalized gift packages.









Memorandum of Understanding with AGBU

On October 19, 2023, a memorandum of understanding was signed with "AGBU" Armenian General Benevolent Union on cooperation to support the ZINAPAH beneficiaries with social projects to support their integration into society.

Memorandum of Understanding with Revival

On November 13, 2023, a memorandum of understanding was signed with Armenian Spiritual Revival Foundation to support the ZINAPAH beneficiaries in their mental health recovery process.





ZINAPAH Development Path to Independence



At its founding in 2017, ZINAPAH was managed by the Central Bank of Armenia (CBA) on a pro bono basis. Since 2021, ZINAPAH began migrating from the CBA to become an independent legal entity with its own infrastructure, and the migration was completed in June 2023.
