About ZINAPAH

ZINAPAH was founded in 2017 to provide stable, equitable compensation for the well-being of the families of fallen, missing-in-action servicemen as well as soldiers with severe and profound functional limitation levels (1st and 2nd category disability) who defended the borders of our Homeland for the peace and security of future generations.

In April 2023, the Foundation previously known as Insurance Foundation for Servicemen (IFS) was renamed ZINAPAH National Foundation for Servicemen Insurance. ZINAPAH is a non-political institution that operates according to the [Law](#).

It is a unique foundation in the region, where every working citizen in Armenia is required to make mandatory contributions from their salaries. **ZINAPAH** represents a pan-Armenian effort to ensure financial well-being for those who have sacrificed their lives for the security of Armenia.

ZINAPAH funds are generated from:

- ✔ **Mandatory monthly payments from 1,500 to 15,000 AMD per month** (based on the amount of income) by taxpayers in Armenia
- ✔ **Voluntary donations received from all over the world, including Armenia**
- ✔ **ZINAPAH asset management appreciation**

ZINAPAH is governed by an independent [Board of Trustees](#), consisting of highly-regarded professionals with stellar reputations and expertise in Finance & Banking, Business, Crisis Management, Fundraising, and Asset Management. ZINAPAH is operated by a highly motivated and experienced Executive Team of professionals.

Dear Friends of ZINAPAH Community,

As we conclude 2025, I am honored to present the Annual Report of the **ZINAPAH National Foundation for Servicemen Insurance** - a year that reflects both institutional maturity and a deepened sense of responsibility toward those who have sacrificed for the security of our nation.

Since its establishment in 2017, ZINAPAH has grown into a unique national institution founded on solidarity, accountability, and shared responsibility. Over the period 2017-2025, the Foundation has provided compensation to **5,510 beneficiaries**, ensuring stable financial support to the families of fallen, missing, and functionally disabled servicemen. In 2025, **28 new cases** were supported, reaffirming our unwavering commitment to those in need.

The year 2025 marked a significant strengthening of ZINAPAH’s financial position. Total income reached **62.0 billion AMD**, representing a **13% increase** compared to the previous year, while total expenses declined by **10%** to **19.6 billion AMD**. This resulted in the strongest positive balance between income and expenditures in ZINAPAH’s history. Our revenues were driven primarily by **49.2 billion AMD in mandatory payments** and a **35% year-on-year increase in asset management income**, which reached **12.6 billion AMD** and now accounts for approximately **20% of total revenues**. Donations amounted to **106 million AMD**.

This financial stability reflects prudent management and improved forecasting, and a year of relative border stability. It has enabled ZINAPAH not only to meet its statutory compensation obligations but also to invest in broader social and integration initiatives for beneficiaries. In close cooperation with the Ministry of Labor and Social Affairs and the Ministry of Defense, we advanced legislative proposals to safeguard compensation continuity for servicemen with functional limitations, regardless of changes in disability classification.

In addition, monthly financial support for families raising children with disabilities was increased, providing meaningful relief to dozens of households.

Beyond financial support, 2025 was a year of expanded social engagement. Through partnerships with governmental bodies, foundations, and NGOs, ZINAPAH continued to build a comprehensive support ecosystem focused on education, employment, rehabilitation, psychological well-being, and community integration. Initiatives such as family camps, educational programs, entrepreneurship training, beneficiary meetings, and the expansion of digital resources on **zinapah.am** reflect our belief that dignity, opportunity, and inclusion are integral to long-term support.

As **ZINAPAH** continues its transition toward full institutional independence, our guiding principles remain unchanged: **transparency, accountability, and integrity**. These values underpin every decision we make and every dram entrusted to us.

We extend our deepest gratitude to the working citizens of Armenia, whose mandatory contributions form the backbone of this pan-Armenian effort; to our donors and partners for their trust and collaboration; and to the dedicated ZINAPAH team, whose professionalism and commitment make our mission possible every day.

Together, we are not only honoring sacrifice—we are building a resilient, compassionate, and unified future for Armenia and its people.

In 2025, ZINAPAH demonstrated a clear strengthening of its financial position, marked by a **13% increase in total income** alongside a **10% reduction in total expenses** compared to the previous year.

This performance reflects a structurally healthier financial model, driven primarily by sustained growth in mandatory payments and a **35% increase in asset management income**, which now accounts for **approximately 20% of total revenues** and plays an increasingly important role in long-term sustainability.

While donation inflows continued their expected normalization following prior extraordinary periods, the overall funding mix became more **stable, diversified, and predictable**, reducing volatility and strengthening financial resilience.

On the expenditure side, **compensation costs declined by 11%**, reflecting a more balanced beneficiary flow, while administrative and operating expenses remained tightly controlled and proportionate to operational needs.

Overall, **2025 represents a transition year** for ZINAPAH toward a more **resilient, capital-driven, and sustainable financial framework**. This strengthened position enables the Foundation to uphold its long-term commitments to servicemen and their families with confidence, discipline, and transparency, while continuing to operate in full alignment with its public mission.

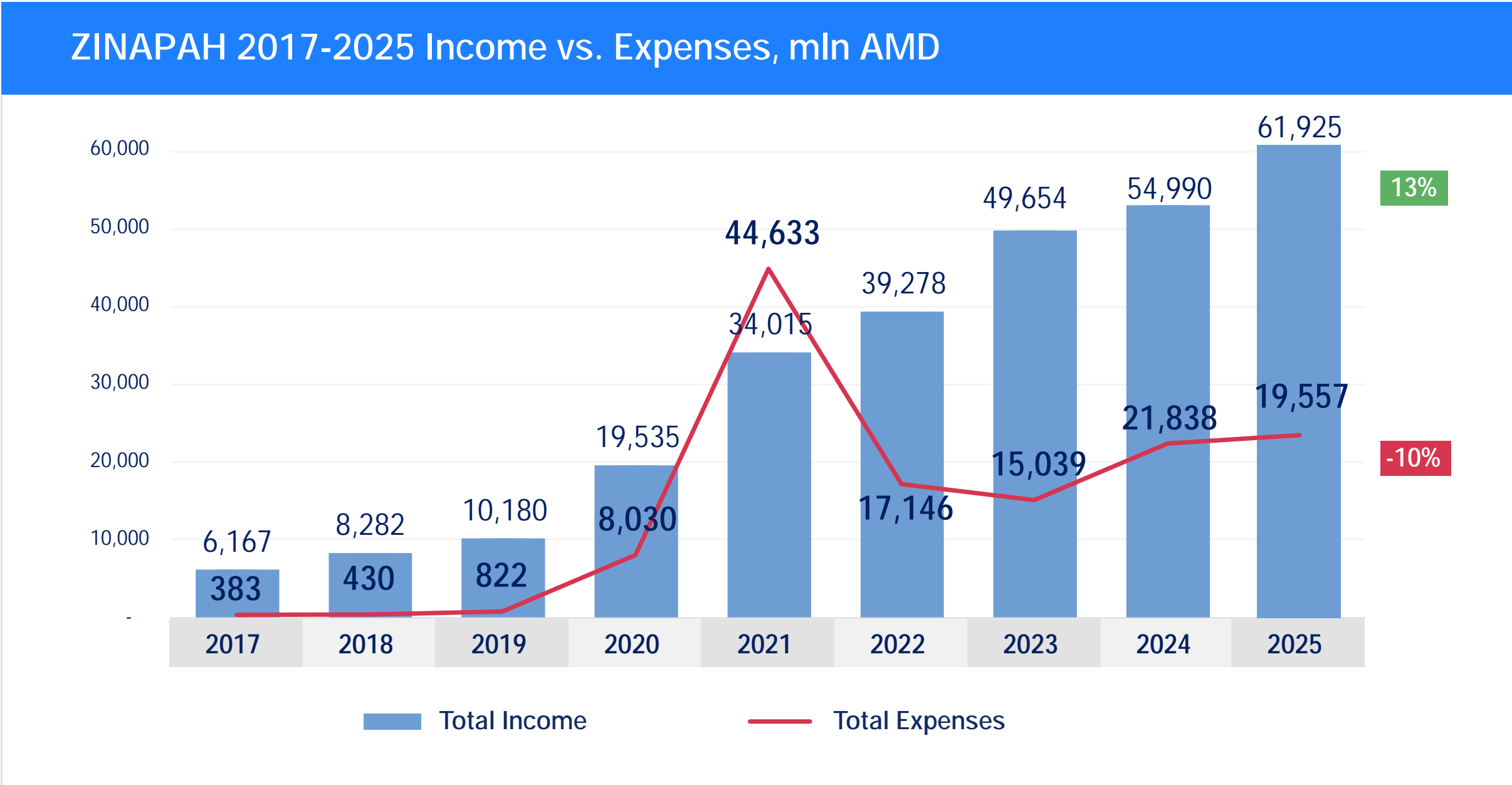

The chart illustrates the evolution of ZINAPAH’s financial model over the period 2017–2025, highlighting both extraordinary years and long-term structural trends.

Following the exceptional surge in 2020–2021—driven by unprecedented national circumstances—ZINAPAH entered a phase of normalization marked by steadily growing income and a more controlled expense trajectory.

From 2022 onward, total income consistently exceeded total expenses, reflecting improved financial discipline and predictability. In 2025, this trend became particularly pronounced, with total income reaching **62.0 billion AMD**, while total expenses declined to **19.6 billion AMD**, creating the strongest positive gap of the period. This widening surplus underscores ZINAPAH’s transition toward a sustainable, capital-driven financial framework, ensuring long-term ability to meet its commitments to servicemen and their families while maintaining transparency, stability, and resilience.



In 2025, ZINAPAH maintained a strong and balanced financial trajectory throughout the year, culminating in a particularly solid fourth quarter. Total income for Q4 2025 increased by **20% compared to Q4 2024**, driven primarily by continued growth in mandatory payments and a **25% year-on-year increase in asset management income**, which accounted for **20% of total revenues in Q4**.

Mandatory payments remained the core funding source, contributing **79% of total income**, while the revenue mix continued to diversify in favor of more sustainable, capital-based sources. Donations, while lower than in the previous year, followed an expected normalization trend and remained supplementary to the overall funding structure.

On the expenditure side, total expenses in Q4 2025 declined by **12% year-on-year**, with compensation costs decreasing, and operating costs remaining tightly controlled.

Overall, both quarterly and annual results confirm that 2025 marked a year of enhanced financial discipline, reduced volatility, and strengthened long-term sustainability, reinforcing ZINAPAH’s capacity to meet its commitments to servicemen and their families with confidence and consistency.

ZINAPAH fully or partially refunds mandatory stamp payments to a parent, spouse, and/or child of a serviceman in compulsory military service, as well as to a parent, spouse, and/or child of a deceased serviceman. The mandatory stamp payment refund process is implemented through the **Stamp Duty Refund Subsystem**, which allows the automatic recording of submitted applications via the ZINAPAH website and the electronic processing of payments.

In 2025, ZINAPAH continued to enhance the efficiency and accessibility of this system, ensuring timely, transparent, and beneficiary-centered service delivery. During the year, a total of **8,132 stamp duty returns** were processed, representing a **22% increase** compared to 2024. The total value of refunded amounts reached **378 million AMD**, reflecting a **25% year-on-year increase**. This growth was driven by improved digital workflows and greater awareness among beneficiaries—particularly parents of conscript servicemen—demonstrating ZINAPAH’s commitment to reducing the financial burden on servicemen’s families through technology-enabled, accountable, and responsive processes.

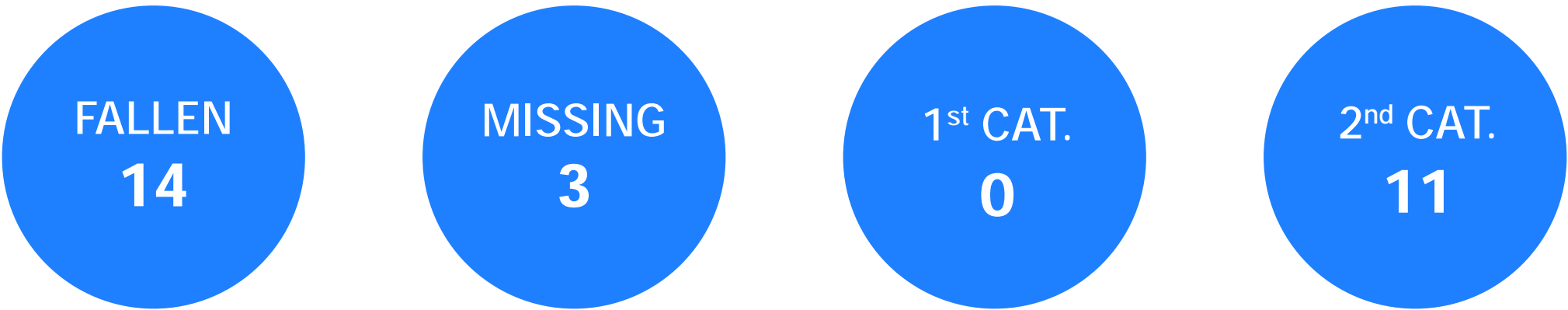

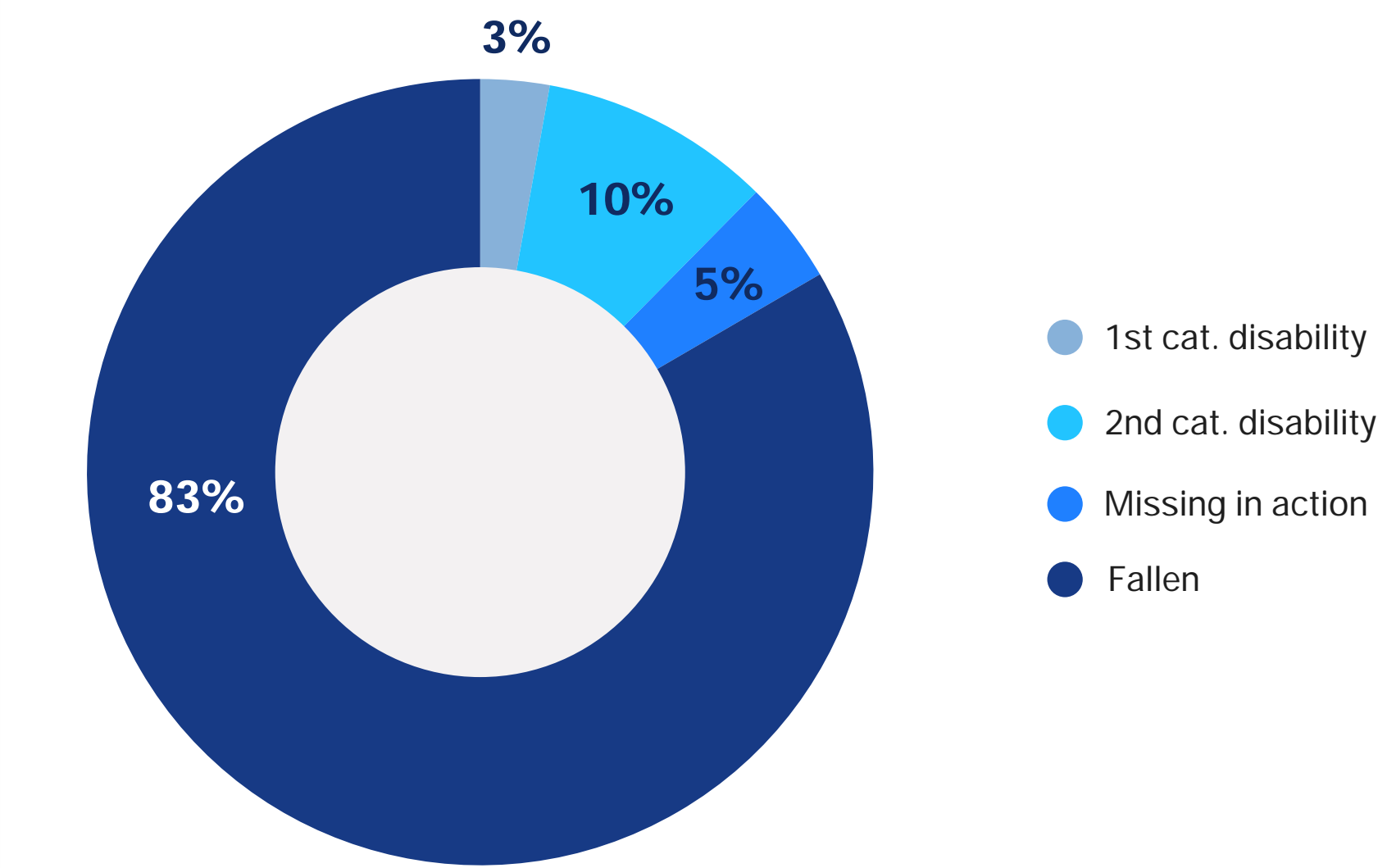
Total Compensated Cases in 2025 Q4 - **5 new cases**



Total Compensated Cases in 2025 - **28 new cases**



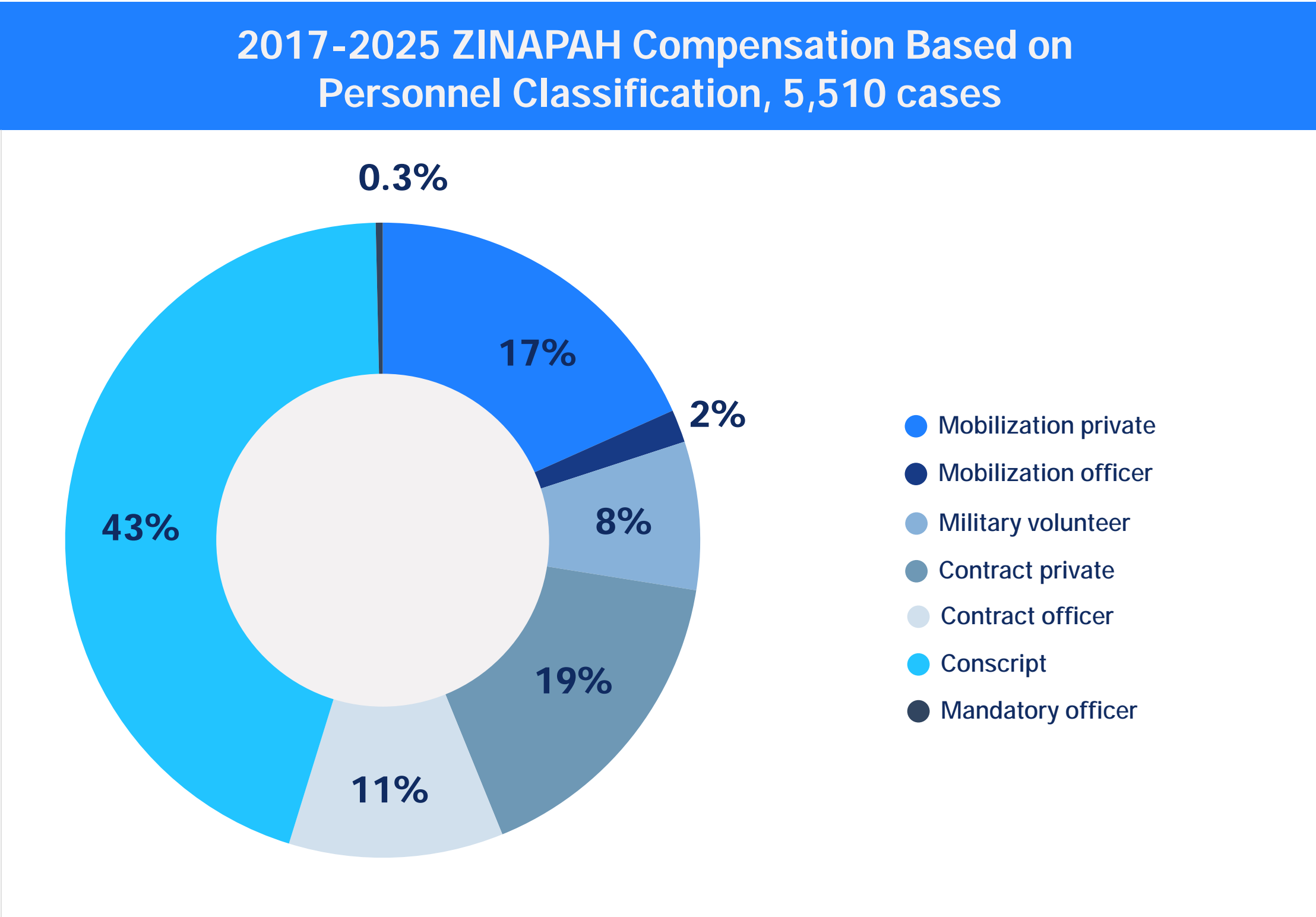
ZINAPAH Beneficiary Breakdown 2017-2025, 5,510 cases

Expanding Partnerships for Comprehensive Beneficiary Support

ZINAPAH continues to strengthen its network of partnerships with **foundations, non-governmental organizations (NGOs), and charitable institutions**, with the shared goal of supporting **servicemen and their families**. These partnerships are focused on ensuring the **social, physical, and psychological well-being** of beneficiaries through coordinated and sustainable initiatives.

To enhance the personal development and long-term well-being of its beneficiaries, ZINAPAH with its partner organizations has launched a range of **social integration and development programs**. A **comprehensive blueprint** for these social programs has been developed, with detailed planning and prioritization for **2025 currently underway**.

ZINAPAH has conducted multiple **consultative meetings** with governmental bodies, NGOs, and partner foundations to align efforts in key areas, including:

- ✔ **Education and skills development**
- ✔ **Economic integration and employment**
- ✔ **Entrepreneurship and business promotion**
- ✔ **Community inclusion and resilience building**

In line with its mission, and with the **support and mediation** of ZINAPAH, a number of joint initiatives have been launched in partnership with various organizations. These initiatives aim to provide **targeted support**, and **relevant information**, and promote **social integration** for beneficiaries across Armenia.

Key events and joint initiatives organized throughout the year, in partnership with various organizations—including AGBU, Armenian Spiritual Revival Foundation, FASF, Innobiz, Hayordi, Heritage and Progress Foundation, Yerevan Park, IRIS Business Incubator, IDBank, Idram, and the Swiss-Armenian Academy of Hospitality—were as follows:

- ✔ **Educational and economic integration initiatives**
Including financial literacy courses, business development and promotion trainings, and scholarship opportunities.
- ✔ **Recreational and inclusivity-promoting events**
Such as the Family Camp, International Children’s Day celebrations, and New Year festivities.
- ✔ **Sports and healthy lifestyle promotion activities**
Including the participation of six ZINAPAH beneficiaries in the 27th Para Arm-wrestling World Championship, as well as first aid training courses.
- ✔ **Mental well-being initiatives**
Including psychological support sessions and team-building activities.



Meeting Held to Address Prosthetic Needs of Servicemen with Lower-Limb Amputations

The Ministry of Labor and Social Affairs, in collaboration with ZINAPAH, hosted a focused meeting to discuss the **challenges faced by ZINAPAH beneficiaries** with lower-limb amputations, which followed a previously organized meeting re upper-limb amputations.

The event brought together beneficiaries and representatives from prosthetics companies operating in Armenia. **Prosthetics companies** showcased modern, more functional prosthetic models. Beneficiaries expressed concerns about the **comfort, usability, and fit** of existing devices. Several issues were **addressed on the spot**; others were recorded for **further follow-up**. Beyond prosthetics, participants also raised **Social and welfare-related concerns**, which were noted for future consideration by relevant state bodies.

The meeting was another **constructive step** toward enhancing the **rehabilitation and quality of life** of disabled servicemen.



Nairi Family Camp for ZINAPAH beneficiaries

ZINAPAH, in collaboration with its partner **FASF** and the **AGBU**, has initiated a three-day family camp designed for the children and wives of fallen and missing servicemen. To bring this initiative to life, ZINAPAH and its partner FASF organized a joint fundraising campaign during the reporting period, successfully reaching the target amount of **\$17,000**.

The Family camp was held on October 24–26 in the city of Tsaghkadzor, with the participation of children and mothers of families of fallen and officially missing servicemen. The camp hosted a larger number of participants than initially planned – 181 beneficiaries of ZINAPAH.

The camp was carried out jointly with ZINAPAH’s partner, the Armenian General Benevolent Union (AGBU), which has long-standing and outstanding experience in organizing camps of this format.

During the three-day camp, participants took part in a variety of educational, psychotherapeutic, and recreational activities. It is worth noting that ZINAPAH’s long-time partner, ID Bank, promptly responded to the initiative and provided free financial literacy courses for the participating mothers.

The purpose of the ZINAPAH initiative was to support family unity and provide social and psychological assistance. The camp gave beneficiaries the opportunity to strengthen community ties, gain new knowledge, and rediscover inner peace.



Cooperation with Innobiz

Within the framework of the Memorandum of Understanding signed in June 2025, ZINAPAH continued its partnership with **Innobiz NGO** to promote entrepreneurship and economic empowerment among beneficiaries. During the reporting year, Innobiz successfully implemented the **From Zero to Business** online educational program on the Innobiz.academy platform, with the active participation of ZINAPAH beneficiaries.

The program is designed to develop entrepreneurial competencies and practical business thinking by guiding participants through the full cycle of designing, launching, and implementing their own business initiatives. It provides structured support, practical tools, and mentorship aimed at fostering sustainable self-employment and long-term economic integration. In total over 130 ZINAPAH beneficiaries were enrolled.

Given the strong interest and positive engagement demonstrated by beneficiaries, an **additional rollout of the program** was announced for ZINAPAH beneficiaries, further expanding access to entrepreneurial education and opportunity.



Cooperation with HAYORDI

As part of its ongoing efforts to support the emotional well-being and social inclusion of beneficiaries, ZINAPAH partnered with the **Hayordi Charitable Foundation** to organize festive community events for children of fallen and missing servicemen. During the reporting period, Hayordi visited the city of **Vedi** in the **Ararat Province**, focusing on families from the region.

A **fairytale-themed New Year celebration** was held at the **Vedi City House of Culture**, creating a joyful and supportive environment for children. The event was filled with festive activities, surprises, and thoughtfully prepared gifts, offering moments of happiness, care, and community connection. Such initiatives play an important role in supporting the psychological well-being of children and reinforcing a sense of solidarity and remembrance within beneficiary families.



Beneficiary Meetings

During the reporting period, ZINAPAH continued to hold a series of beneficiary meetings aimed at reinforcing its mission, strengthening engagement, and sharing key information on rights, available programs, and services. These meetings served as an essential platform for **two-way communication**, enabling beneficiaries to raise concerns and receive direct responses through structured Q&A sessions.

In the **fourth quarter of 2025**, meetings were organized in **Ejmiatsin, Armavir Region**, and **Tsaghkadzor, Kotayq Region**, with the participation of approximately **125 beneficiaries**. Over the course of **2025**, a total of **11 meetings** were held, engaging **more than 340 beneficiaries** across various regions.

Key Issues and Suggestions Raised during these meetings included:

- ✔ The need for enhanced **housing support**
- ✔ Improved access to **healthcare services**
- ✔ Consideration of lump-sum compensation for families of fallen or missing servicemen and disabled service members for cases preceding 2017

The meetings reaffirmed that beneficiaries continue to face a range of challenges requiring clarification, advocacy, and support. Regular engagement through such meetings remains a crucial mechanism for addressing these issues, fostering trust, and facilitating the development of tailored responsive solutions. ZINAPAH remains committed to sustaining these efforts to ensure a meaningful impact for its beneficiary community.



Introduction of the Supporting Programs
Subsection on Zinapah.am

In 2025, ZINAPAH introduced new website subsections—**Supporting Program** and **Useful Links**—on zinapah.am, expanding digital access to information and opportunities for beneficiaries. These sections provide regularly updated details on programs offered by ZINAPAH partner organizations, as well as initiatives implemented by Armenian government agencies.

A key benefit of this initiative is that beneficiaries can **apply directly** for listed programs, opening new pathways for support, professional training, education, and personal development. To ensure broad awareness and accessibility, the new subsections were actively promoted during ZINAPAH’s **monthly regional meetings** throughout 2025, where beneficiaries were introduced to the available programs and participating partner organizations.

This initiative is designed to **strengthen ZINAPAH’s support network** and empower beneficiaries through improved access to resources, facilitating their successful social and economic reintegration and reinforcing ZINAPAH’s commitment to long-term, sustainable impact.



At its founding in 2017, ZINAPAH was managed by the Central Bank of Armenia (CBA) on a pro bono basis. Since 2021, ZINAPAH has begun migrating from the CBA to become an independent legal entity with its own infrastructure.
